Your Excellency,

I have the honour to refer to our discussions in relation to temporary employment entry for nationals of the Republic of Korea to work in specified skilled occupations in New Zealand.

Based on these discussions, I further have the honour to confirm that the Government of New Zealand will take the following measures from the same day as the *Free Trade Agreement between the Republic of Korea and New Zealand* enters into force:

1. New Zealand will allow an overall total of up to two hundred (200) Korean professionals from the skilled occupations listed below and ordinarily resident in the Republic of Korea to enter New Zealand at any one time, for a period of up to three (3) years, provided that they:

- (i) have a bona fide job offer from a New Zealand employer in the relevant occupation category under which they are applying for entry;
- (ii) have a relevant degree level (Level 7 or above) qualification or relevant work experience as required by Immigration New Zealand; and
- (iii) hold New Zealand registration, where required.

Forest Scientist	Bachelor of Forestry Science or equivalent

Food Technologist	Bachelor of Food Science or equivalent and a minimum of three years' relevant post-qualification work experience in the industry
Veterinarian	Bachelor of Veterinary Science or equivalent and registration with the New Zealand Veterinary Council
Software Engineer	Bachelor of Engineering or equivalent

2. Entrants under any single occupation category may not exceed the individual occupation cap of fifty (50) Korean professionals in New Zealand under these measures at any one time.

3. New Zealand will not require labour market testing, economic needs testing or other procedures of similar effect. Applicants must fulfil all other immigration requirements for applicants applying to work in New Zealand, including health and character requirements.

4. Korean nationals who have spent three (3) years in New Zealand working under these measures are not eligible to apply to re-enter New Zealand under these measures unless they have spent a minimum of three (3) years out of New Zealand. For greater certainty, Korean nationals will still be able to apply for a different visa during their stay.

5. For the purposes of ensuring the effective implementation and operation of these measures, unless otherwise jointly decided, the Republic of Korea and New Zealand will meet within three (3) years after the first day of implementing these measures, and thereafter as jointly decided by the Republic of Korea and New Zealand, to review the specified skilled occupations outlined in these measures, and any mutually determined changes will be implemented in accordance with the outcome of the review.
